Steps in Application Procedure

1. Receive an application from Cooperative Extension Office.
2. Application will be pre-approved by a staff member of Cooperative Extension, Soil and Water, Natural Resources Conservation Service, and Tax Department.
3. Application will be given final approval by the Warren County Agricultural Advisory Board at a regular monthly meeting.
4. Applicant will be notified in writing after final approval of the farm for a Voluntary Agricultural District.
5. Information will go to the Register of Deeds and Tax Office for mapping.
