**To be eligible for a sign-on bonus, the candidate must not have worked as a probationary, permanent, or time-limited employee in the last 12 months as an employee subject to the State Human Resources Act or Warren County's Personnel Manual.**

**POSITION:** Public Health Nurse II\* - Chronic Disease

**DUTIES:** The primary purpose of this position is to provide nursing services & promote lifestyle changes to individuals through Health Risk Assessments, Exerstyle-Plus Program, Chronic Disease Management education and self-management skills. This position will coordinate all aspects of the Health Department's Exerstyle Plus Program; collaborates with Health Department Staff & other Agencies to create a Chronic Care Team; assists in planning and developing a program that provides services for chronic disease management; assists with outreach in the community & serves as back-up for Communicable Disease/TB program.

**EDUCATION/EXPERIENCE:** Must be licensed to practice as a Registered Nurse in North Carolina. Graduation from an accredited school of professional nursing & 2 years of professional nursing experience, including 1 year of public health nursing experience; or an equivalent combination of education & experience is required.

**SPECIAL REQUIREMENTS:** Valid driver's license in good standing; licensed to practice as a Registered Nurse in North Carolina; must meet & maintain minimum education & experience requirements as determined by the state of North Carolina.

**SALARY:** \$47,305 - \$73,322 annually
